

# **Expiration of Temporary Conditions**



- Tier 3 Temporary License
  Conditions expired in June
- USG decided to seek extensions
- Conducted interagency coordination to establish standard procedures



## **License Format Update**

- Conducted Enforceability Review
- Recommendations approved by CRSRA General Counsel
- Licenses will be converted following annual certification





# **Compliance Update**

FY22 Annual Compliance Certification (ACC) Metrics\*

92 Open Licenses Required Recertification by October 15th

- 82 have been submitted to date
  - 56 on time / 26 late
  - 40 certified with no modifications
  - 42 certified with modifications required
    - $_{\odot}$  25 modification requests received
    - o 17 requests have not been submitted
- · 2 licenses were closed
- 8 have not responded
- 1 new license opened


# **Ground Station Inspections\***

- Inspections paused March 2020
  - 300+ sites now require inspection
- Inspections resumed July 2021
  - 22 Inspections in FY21
  - 12 MCCs and 10 Ground Stations
  - 7 investigations
- FY22 Plan
  - Fully resume inspection activities
  - Domestic and overseas locations
  - 75-100 inspections expected


